



- Administrative access for everyone
- No IT policy
- Systems not up to date
- Expired software
- No inventory

93% of breaches could have been avoided.

- Email security
- Staff security awareness training
- No MDM policy



91% of all cyberattacks begin with a phishing email.

- No email & data retention setup
- No password vault
- Limited or no security monitoring
- No supplier due diligence
- Dark Web scanning

41% of internet users manage passwords across 10 to 25 websites and apps.






